## IOM Reintegration Assistance for Returnees to Moldova

IOM Helsinki here forwards you some updated information on reintegration services for IOM Assisted Voluntary Returns to Moldova.

In view of ensuring sustainable return, IOM Chisinau and partners have developed a national network for delivery of reintegration services at the local level, covering the entire territory of Moldova (except for Transnistria).

IOM reintegration services in Moldova can now be offered with relatively low administrative costs to e.g. Nordic governments. Different types of assistance can be selected on the beneficiary's individual needs.

Reintegration assistance can amongst others include:

- IOM reception assistance at Chisinau Airport, payment of reinstallation grants, transit accommodation, onward transportation to final destination;
- Vocational training courses, purchase of professional equipment;
- Study support, assistance in finding employment, support for small business start-up etc;

The attached document gives an indication of the costs of specific reintegration activities per returnee. Reintegration assistance costs offered on a case-by-case basis may differ from the mentioned figures.

For Assisted Voluntary Returns to Moldova from the Nordic countries, IOM Helsinki will make the travel arrangements and coordinate possible reintegration assistance and reporting with the IOM mission in Chisinau.
